
- Source to Pay includes processes to procure materials, inventory materials and make payment to suppliers

- Engineer to Release includes management design drawings, enterprise wide changes to drawing documents, products, processes, materials and also incoming materia quality.
- Project Setup to Close: includes integration of project processes to support the modules and EPC businesses.
- Supplier Relationship Management (SRM) integration with vendors
- Advanced Planning and Optimization Implementing of Supply Network Planning (SNP) and Demand Planning (DP)
