## The Need

The current reporting needs were addressed by accessing data from multiple data warehouses sourced from multiple source systems. The need was to create a centralized repository of leasing data with a centralized data warehouse.

## The Solution

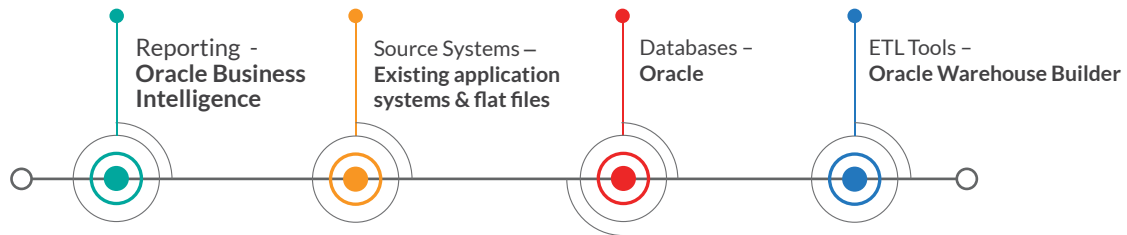
- Developed a centralized enterprise data warehouse, holding data from all multiple source systems and provided a comprehensive integration with existing reporting systems.
- Execution was carried out in multiple phases – the first phase implementing a system for capturing incremental data loads and the second phase involving assimilation of all incremental data into one DWH mode.
- Provided support for the centralized data warehouse.

- Decrease in overall administration and management effort by leveraging improved methodologies in data capture, retention, analysis, and loading
- Collation of all information into one data source, thus removing complexity in having multiple data centers
- Decrease in total cost for the customer by implementing systems for partial data loads thereby drastically bringing down process run times and ensuring more effective utilization of database resources
